Overview: The Fiscal Year 2023-24 Annual Budget includes costs for the

Commission's outstanding retirement liability payments and

residual wind down expenses.

Recommendation: Adopt the attached Resolution approving the Fiscal Year (FY)

2023-24 Annual Budget (EXHIBIT 1)

Background: The FY 2023-24 Annual Budget includes \$75,632 in funding to

address anticipated expenditures. Specifically, the FY 2023-24 Annual Budget includes costs for the retirement liability payment required by CalPERS (\$67,632) and costs associated with accounting functions to meet requirements resulting from continuing the organization in existence (\$8,000). This cost is higher than in prior years due to a potential increase in audit cost associated with required auditor rotation. Though the actual cost is not known, this estimate is designed to cover both the accounting fees for necessary preparation work and the audit fee. Using a liberal estimate for expenditures to be incurred through year-end to prepare for the biennial audit in case \$3,000 of expenditures are incurred before year end, we are assuming there will be a \$1,000 fund balance remaining at June 30, 2023 that will roll forward and be available to finance FY 2023-24 expenditures. Therefore, the anticipated revenue from the County and City is \$37,316 from each, assuming both contribute the full budgeted amount. If \$3,000 is spent before FY 2023-24 begins, that will likely reduce the accounting expenditures in FY 2023-24 below the \$8,000 included in this budget, but the full \$8,000 has been included nonetheless to avoid budgetary issues resulting from delayed payments. No assurance is

provided.
